#### 1.0 **RESPONDENT'S PRICING AND DELIVERY PROPOSAL:**

Having carefully examined the premises and all the conditions affecting the work, the Uniform General Conditions for The University of Texas System Building Construction Contracts (UTUGCs), the Construction Documents, and addenda thereto, as prepared by, Courtney Harper & Partners Architects, the Project Architect/ Project Engineer on this Project, the undersigned proposes to furnish all labor, materials, and equipment necessary to achieve Substantial Completion of the Work in accordance with the Owner's Standard Agreement and the Construction Documents for the following sum. The above Proposed Price for Base Scope of Work includes the following Owner's

Special Cash Allowance for Work to be done within this contract under the supervision of the Contractor and/or its Subcontractors. This allowance shall be listed on the Contractor's Proposed Price Breakdown as a portion of the total Contract Sum, and shall be expended only upon direction of the Owner. This is a lump sum amount from which expenditures are to be paid in accordance with the Changes section of the Uniform General Conditions for The University of Texas System Building Construction Contracts. Any unused amount will be deducted from the Contract Sum by Change Order.

Schedule of Allowances Allowance no. 01. Include the sum of:

## Thirty Thousand and 00/100 DOLLARS (\$30,000.00) for the following work:

The allowance shall be utilized by the General Contractor for the engagement of Siemens to perform the El Rio E Building BAS connection to the MD Anderson main central monitoring Siemens system. Tridium Niagara 4 shall be the BAS framework utilized for the El Rio E Building. Siemens will receive the El Rio E Building monitoring points from the MDA network and program them into the MDA central monitoring system (Siemens based).

All other work related to the BAS framework and installation is to be performed by one of the acceptable BAS subcontractors as described in the Project Documents. The work scheduled to occur at the El Rio E Building is NOT covered until Special Cash Allowance and is to be included in the Base Proposal.

### 1.1.3 INSURANCE COVERAGE OF EXISTING BUILDING STRUCTURE:

The above Proposed Price for Base Scope of Work/Proposal Cost includes a cost for Builders Risk Endorsement Coverage in the amount of \$5 million *or* the estimated replacement value of the existing building structure, whichever is less. This coverage is for the existing building structure as further defined in Owner's Special Conditions, Article 2, Builders Risk Endorsements.

- 1.8 <u>LIQUIDATED DAMAGES</u>: The undersigned agrees that, from the compensation otherwise to be paid, the Owner may retain the sum of **Two Hundred Dollars** (**\$200.00**) for each calendar day after the Substantial Completion Date that the work remains incomplete, which sum is agreed upon as the proper measure of liquidated damages which the Owner will sustain per diem by the failure of the undersigned to complete the work within the time stipulated in Agreement. This sum is not construed in any sense as a penalty.

In addition, the undersigned agrees to execute and deliver to the Owner with the executed Agreement, a certificate of insurance to verify that Respondent has secured required insurance for the Project in compliance with the requirements set forth in the Agreement and the UTUGCs, the executed Payment and Performance Bonds, and a Certification of Franchise Tax Payment. The undersigned further agrees to obtain from each Subcontractor and supplier, and hold for redelivery to the Owner if requested, a certification of franchise tax status of such Subcontractor or supplier.
- 1.12 <u>OWNER'S RIGHT:</u> It is understood that the Owner reserves the right to accept or reject any and all Proposals and to waive proposal irregularities. It is further agreed that this Proposal shall be valid and not withdrawn for a period of ninety (90) days from the date of opening thereof.
