1.0 **RESPONDENT'S PRICING AND DELIVERY PROPOSAL**

Having carefully examined the Uniform General Conditions for The University of Texas System Building Construction Contracts (UTUGCs), the Construction Documents, and addenda thereto, as prepared by Hellmuth Obata + Kassabaum, Inc., the Project Architect/ Project Engineer on this Project, the undersigned proposes to furnish all labor, materials, and equipment necessary to achieve Substantial Completion of the Work in accordance with the Owner's Standard Agreement and the Construction Documents for the following sum. 1.1.3 INSURANCE COVERAGE OF EXISTING BUILDING STRUCTURE: The above Proposed Price for Base Scope of Work/Proposal Cost includes a cost for Builders Risk Endorsement Coverage in the amount of \$5 million *or* the estimated replacement value of the existing building structure, whichever is less. 1.3 UNIT PRICES FOR GENERAL CONSTRUCTION: The undersigned further agrees that, in case additional work or material is authorized from what is shown in the Construction Documents, the following unit prices shall be used in adjusting the Contract Sum. The unit prices include overhead, profit, taxes, etc. in accordance with the Changes section of the UTUGCs. Unit prices to be used for adjusting the Contract Sum for less work or material will be 75% of these amounts for the net difference of the total quantities for each type of work.

1.4 PROPOSED ALTERNATES: Respondent shall expressly identify any alternate means, methods or materials ("Proposed Alternate(s)") it intends to use in completing either the Base Scope of Work or any Alternate Scopes of Work. Respondent shall identify the impact that such Proposed Alternate will have on Respondent's Proposed Price for Base Scope of Work or Respondent's Proposed Price for Alternate Scope of Work to which the Proposed Alternate is related, as well as any impact the Proposed Alternate will have on the Construction Duration. Respondent shall identify all Proposed Alternates on a separate page or pages and attach any such page or pages to this Pricing and Delivery Proposal.

1.5 CONSTRUCTION DURATION: The undersigned agrees, if awarded the contract, to achieve Substantial Completion of the Work as described in the UTUGCs, the Construction Documents and addenda thereto within one hundred eighty, 180 calendar days after the Date of Commencement set forth in the Notice to Proceed with Construction.

- 1.8 LIQUIDATED DAMAGES: The undersigned agrees that, from the compensation otherwise to be paid, the Owner may retain the sum of **TWO HUNDRED DOLLARS AND NO/100, (\$200.00)** each calendar day after the Substantial Completion Date that the work remains incomplete, which sum is agreed upon as the proper measure of liquidated damages which the Owner will sustain per diem by the failure of the undersigned to complete the work within the time stipulated in Agreement. This sum is not construed in any sense as a penalty.
- 1.9 PROPOSAL BONDS: NOT USED
- 1.10 PAYMENT AND PERFORMANCE BONDS: The undersigned agrees to execute the Payment and Performance Bonds within ten (10) calendar days, in the amount of one hundred percent (100%) of the Contract Sum, after notification that the Respondent has been identified by the Owner as the Respondent with the “best value” Proposal.
- 1.11 AWARD OF CONTRACT AND COMMENCEMENT OF WORK: The undersigned agrees to execute the Agreement within ten (10) calendar days after notification that the undersigned has been identified by the Owner as the Respondent with the “best value” Proposal, and to commence work on or before the commencement date stated by the Owner in a Notice to Proceed with Construction; such commencement date shall be ten (10) or more calendar days after the date of the Notice to Proceed. In addition, the undersigned agrees to execute and deliver to the Owner with the executed Agreement, a certificate of insurance to verify that Respondent has secured required insurance for the Project in compliance with the requirements set forth in the Agreement and the UTUGCs, the executed Payment and Performance Bonds, and a Certification of Franchise Tax Payment. The undersigned further agrees to obtain from each Subcontractor and supplier, and hold for redelivery to the Owner if requested, a certification of franchise tax status of such Subcontractor or supplier.
- 1.12 OWNER’S RIGHT: It is understood that the Owner reserves the right to accept or reject any and all Proposals and to waive proposal irregularities. It is further agreed that this Proposal shall be valid and not withdrawn for a period of ninety (90) days from the date of opening thereof.
